

## Terms of use

This website, accessible at motyl.com.au and its related services, products, websites, tools and applications is owned and operated by Motyl Interiors Pty Ltd and Motyl Shopfitters Pty Ltd ("Motyl Group"). By accessing and using the Website you agree to the following terms. We may update these terms from time to time at our discretion without notice to you. The updated terms come into effect upon publishing. Accordingly, each time you use our Website you should revisit these Terms of Use.

# **Definitions and Interpretation**

## 1.1 Definitions

In these Terms of Use unless inconsistent with the context or subject matter:

- (a) Account means a User's online account to use our Website;
- (b) Applicable Laws means any applicable laws (including orders, by-laws and regulations) in the jurisdiction in which you are located or which in any way govern or affect the use of the Services;
